Day 4: New York City

This morning, drive through the Wall Street district on your way downtown, reflect at the 9/11 Memorial and take a self-guided tour at the 9/11 Museum - two poignant tributes to the lives lost. This evening, join your fellow travelers for a final toast as we gather for dinner at a local restaurant. Then, it's off to exhilarating Times Square to take your seat at an included Broadway show! You'll choose from a selection of Broadway's biggest hits.* *Today breakfast and dinner will be included.*

For 80 years, the theater has hosted the holiday tradition of the Radio City Christmas Spectacular, starring the world-famous Rockettes. Referred to as the best holiday production in America, the Christmas Spectacular draws an audience of one million people every year. This show blends the flawless choreography of the prestigious Rockettes with an abundance of holiday pizzazz. Their precise moves, the upbeat holiday music, and the elaborate costumes and stage décor are simply captivating.

to miss a thing, so walking and standing for longer periods of time (2-3 hours) isn't a big deal. A moderately paced two-and-a-half-hour walking tour, covering several miles, hills, and uneven surfaces, is no problem for you. Walking four miles over the course of a day is very doable, as is climbing into and out of various modes of transportation (tuk-tuk, cable car, zodiac, etc.). You can climb three flights of stairs easily and handle altitudes between 6,000 and 9,000 feet. Expect some longer days with early mornings or late nights balanced with free time to recharge or set out on your own adventure. This level is not a fit for travelers who require mobility assistance devices.

Please be prepared for the rain or snow during the winter months, as walking to our dinner restaurants may require up to 0.75 miles each way.

If you require any special assistance while on tour, please make us aware at time of reservation so the necessary request form can be sent to your attention.

*For the matinee Broadway performance, travelers will be provided with a selection of shows to choose from. Selection of shows is subject to change based upon availability. Actual shows available for choices will be advised approximately 80 days prior to departure and must be finalized at 50 days prior to departure. Day of the Broadway show and performance selections are subject to change. Once travelers choose show of preference, changes are not permitted. Some Broadway performances may not be suitable for children; please inquire at time of reservation.

Due to ticket availability, the day of the Radio City Music Hall performance is subject to change.

The days and order of sightseeing may change to best utilize your time on tour.

When reserving a triple room, please note that it will have two double beds. Due to fire safety regulations, a rollaway bed cannot be brought into the room.

Single accommodations are limited and are available on a first-come, first-served basis. Single rate subject to change based on availability.

To complete your tour, we include roundtrip airport-to-hotel transfers when purchasing our airfare with your tour. If you have arranged for your own air, we are pleased to provide you the option of *purchasing* these transfers. Please note that all transfers will leave at pre-scheduled times.

For air-inclusive reservations, the name provided at time of booking must match your government-issued ID that will be used during travel. Name changes are subject to penalties.

Please be advised many airlines do not provide advance seat assignments until check-in at the airport. Advance seating will be subject to the airline's terms and conditions.

Travel Requirements:

IDENTIFICATION

Travel within USA

For travel completed by May 6, 2025, all airlines will ask for identification when you check in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

Effective for travel May 7, 2025 forward, the REAL ID Act standards for identification while travelling will be in effect. This means a standard issued driver's license used as a form of identification will no longer be accepted for domestic air travel within the United States. Instead, a Real ID compliant form of identification must be presented both at the time of booking air travel with Collette and upon checking in at the airport to board any flight. Any fees associated with changing a reservation resulting from a non-compliant identification will be the responsibility of the guest. Important reservation information:

***Airfare:** For your convenience, we offer airfare for purchase with all tour packages. If you purchase an air inclusive program, your airfare will be quoted inclusive of all fuel, taxes and fees. Your price is guaranteed once deposit is received by Collette. Your price is not subject to increase after the deposit is received, except for charges resulting from increases in government-imposed taxes or fees. Preassigned seats are limited and may not be available on every flight or departure date.

Checked Baggage Charges: Some airlines may impose additional charges if you choose to check any baggage. Please contact your airline or refer to its website for detailed information regarding your airline's checked baggage policies.

Cancellation Charges for this tour: After your seat reduction date has passed, a non-refundable deposit will be retained. For Cancellation between 90-16 days prior to departure: cancellation fee of 40% of total price. For cancellation between 15-1 days prior to departure: cancellation fee of 75% of total price. For cancellation on the day of departure and after: 100% of total price. For Ocean Cruises: For cancellation between 90-61 days prior to departure: cancellation fee of 40% of total price. For cancellation between 60-31 days prior to departure: 60% of total price. 30 or fewer days prior to departure: 100% of total price. For River Cruises: including Europe, Russia, Egypt and China, 90-61 days prior to departure: cancellation fee of 50% of total price. Cancellation waiver protects you from penalties in the event you have a need to cancel your entire inclusive tour package up to the day prior to departure. Cancellation waiver does not indemnify you from penalties if you chose to cancel partial tour components or air. If you chose to partially cancel your vacation, you will be responsible for a revision fee as well as any penalties that are incurred at the time of the cancellation. Upon cancellation of transportation or travel services where you, the customer, are not at fault and have not canceled in violation of the terms and conditions above, you will be refunded 100%. If you make your own air reservations, Collette is not responsible and shall provide no refund if your flight schedule changes so that you are not able to enjoy the entirety of your tour. All services and accommodations are subject to the laws of the country in which they are provided. Collette reserves the right to make changes in the published itinerary whenever, in their sole judgment, conditions warrant, or if Collette deems it necessary for the comfort, convenience, or safety of the tour.
